The Government has been clear on what it believes is the extent of the financial challenges that the country faces, and most expect some tough decisions that will impact personal and family budgets, which will no doubt impact consumer attitudes and spending patterns.

And whilst the debate over the proposed changes to the Winter Fuel Allowance will no doubt continue to dominate the headlines in the coming weeks, we'll be keeping a close eye on whether there'll be any significant change to the business rates system, and anything else that will impact BIDs, our levy payers, and partners.

As such, this year's **British BIDs National Conference - on Thursday 7 November** - is extremely well timed. And we are delighted that **Catherine Bennion, Deputy Director at the Ministry of Housing, Communities and Local Government** will be one of our key speakers. Catherine's responsibilities include high streets and communities, and she will provide an overview of the Government's policies and priorities. He sits on the Social Value UK Advisory board, the national membership body for social value. This promises to be a timing and informative session.
